
CONTINUING MEDICAL EDUCATION

Cincinnati Children's was the first hospital in the state of Ohio to earn Joint Accreditation for Interprofessional Continuing Education. This designation recognizes Cincinnati Children's commitment to team-based care and education, allowing us to award physician, nursing, pharmacy and physician assistant credit where appropriate for our educational programs and activities. CME activities are offered in a variety of formats and are available to participants regardless of affiliation with our hospital, including:

MOC PART 4

Cincinnati Children's has worked very closely with the American Board of Pediatrics for over a decade to develop programming that allows physicians to earn MOC Part 4 credit for their meaningful participation in quality improvement (QI) work they are already doing. We are also an approved sponsor organization in the American Board of Medical Specialties Multi-Specialty Portfolio Program (MSPP), allowing us to extend MOC Part 4 credit beyond pediatricians to our entire medical staff. This alignment of individual requirements with organizational priorities enables physicians to focus on the most critical improvement opportunities in their practice instead of jumping through hoops to check boxes. Types of approved activities include:

- National, regional, and local multi-site learning networks and improvement collaboratives
- Hospital-based improvement projects
