#### Family Therapy

- Maintain a caseload of about 30 students, including students in need of mental health and academic support.
- Collaborate with school personnel and community agencies to support student wellness.
- Facilitate bi-weekly meetings with the Tiered Support team to manage Tiered Support provider's caseloads, track progress towards goals, assess school-wide trends, and provide consultation.
- Create and utilize data systems to collect and monitor student progress and retention in the Tiered Support program, which includes reviewing attendance, behavioral incidents, number of contacts with a tiered support provider, and overall satisfaction with the Tiered Support program.
- Lead Student Success Team meetings centered on student strengths and goals.
- Assist in developing and implementing a wide range of Tiered 1, 2 and 3 accommodations and tools.
- Support teachers in the classroom by diversifying instruction and creating a more trauma-focused learning environment.
