Efficiency Gains

Prior to using the M.I.N.I., Dr. George was using a series of pen and paper in-house checklists and tools that were based on DSM-5 criteria as part of his evaluations. Now, he has the flexibility of emailing the diagnostic interview to the patient or caregiver as part of the initial intake process, which helps quickly clarify potential diagnostic impressions.

Dr. George is also able to use the report generated by the nView electronic assessment to assist in requesting prior authorization from insurance companies when further psychological testing may be needed. The comprehensive report can be easily converted to a PDF and used to show the patient or referral source which diagnostic criteria were identified as the basis for the individual's diagnosis. Not only does this help educate the referral source, patient, or caregiver, but it helps build trust through transparency with referral sources and patients, which ultimately helps grow the practice.

Powerful Insights

As digital technology has become a primary means of communication among people among all ages, Dr. George often finds that patients are more forthcoming with information when they can respond in the privacy of their own home or personal space. For example, one of his referral sources recently sent him an adolescent patient who had experienced multiple traumatic events in her past that had resulted in drug abuse, signs of an eating disorder, and withdrawal from family and friends. Prior to the first visit, the patient completed the M.I.N.I. assessment, endorsing many concerning diagnostic criteria that were consistent with other sources of information. In person, the patient became extremely defensive and guarded when asked certain questions, and as a result provided limited information.

Multiple Modules for Any Situation

Dr. George's practice sees a wide variety of patients, including all ages and conditions. He appreciates the fact that the nView Solution offers multiple modules in one platform that evaluate for up to 17 adult and 24 pediatric commonly diagnosed DSM-5 disorders and other related disorders. For example, when an adolescent is being evaluated, Dr. George will administer the M.I.N.I. Kid that has language that is appropriate for adolescents. In addition, he asks the parents or other members in the patient's circle to complete a version of the assessment that uses appropriate language to help them report on what they have observed. By getting a more wholistic view, he is able to more accurately diagnose the patient.

In addition, Dr. George uses certain nView modules for specific evaluations. For example, he has seen a recent surge in the number of referrals for child and adult ADHD evaluations from primary care physicians who are becoming increasingly uneasy with this diagnosis, especially when diagnosis is complex due to overlapping symptoms and conditions. The comprehensive nature of the nView Solution allows him to quickly evaluate the patient's ADHD symptoms while also uncovering underlying conditions that may be contributing to the patient's challenges.

Preparing the Next Generation

With the ongoing shortage of trained mental health professionals, Dr. George's work with giving doctoral candidates and post-doctoral fellows hands-on training is equally as important as the work he does with patients.

"When working with students, I've found the M.I.N.I. score report to be extremely helpful in that it hits on so many different diagnostic possibilities. It helps students better understand what questions to ask, various ways to word questions during an in-person interview, and even how to elicit conversation with the patient."

Dr. George sees many other advantages of students working with the nView Solution during their training.
