

NCMEC RESOURCES FOR CHILD SEXUAL EXPLOITATION SURVIVORS THEIR FAMILIES

NCMEC is here to help survivors and families impacted by online child sexual exploitation. Our team can provide free assistance and support by discussing legal issues, providing counseling recommendations, identifying community support and offering guidance on removing child sexual exploitation content from the Internet.

Seek counseling and community resources

NCMEC provides assistance to families who need help coping with a missing or sexually exploited child. We offer crisis intervention to families as well as local referrals to appropriate professionals for longer-term support.

Find family support

NCMEC has a network of trained parent volunteers who have been impacted by the sexual exploitation of a child and can provide guidance and support to families in similar situations.

Remove images, videos, and comments online

NCMEC works closely with technology industry partners to help reduce child sexual exploitation images that circulate on the Internet and stop the posting of harassing online comments. We also can share resources, guidance, and tools to help you remove child sexual exploitation photos and videos from the Internet.





Locate an attorney to help you understand your legal rights and pursue monetary restitution

A child whose sexually exploitative photos are shared online has a legal right to seek monetary restitution from all offenders who create, share, or possess these images. Because the process to seek monetary restitution is complex and often confusing, it is helpful for you to have an attorney when you navigate the legal system. NCMEC can talk you through these legal issues and help find an attorney who will work on your behalf.

Child Sex Trafficking Recovery Services Team (RST)

The National Center for Missing & Exploited Children (NCMEC) is available bprovide specialized technical assistance, support, and resources to child welfare and other child-serving professionals working with missing children who are victims of child sex trafficking.

RST Resource Specialists are assigned to multi-state regions and available to offer the following assistance for cases involving child sex trafficking:

- » Share promising practices in trauma-informed responses and reducing running behavior
- » Provide case-based assistance in the development of trauma-informed and victim-centered recovery plans
- » Connect professionals to local and national resources that provide specialized services

- » Provide resources and support on meaningful youth engagement, effective approaches to trauma responses, strategies to address and reduce running behavior, and safety planning
- » Provide training and assist with protocol development
- » Support multidisciplinary efforts to prevent revictimization

Why Recovery Planning?

When a survivor of child sex trafficking is recovered or returns to child welfare care, it is a disruption, or a pause, in their victimization. Recovery Planning recognizes this disruption as an unparalleled opportunity to begin to break the cycle of exploitation through intentional, planned, trauma-informed, and victim-centered engagement. Informed and specialized engagement at the time of and following recovery, has the potential to discredit the lies and manipulation of a trafficker and start to build the foundation of healthy, caring relationships.

Professional Referrals

Families coping with a missing or exploited child may need help from therapeutic providers who understand how a family and community are impacted. Our Family Advocacy Outreach Network (FAON) is a diverse network of licensed mental health consultants who provide brief or ongoing therapeutic care on a sliding-fee scale or at no charge. Missing Kids Readiness Program

What is the Missing Kids Readiness Program?

The Missing Kids Readiness Program (MKRP) promotes policies and best practices for responding to calls of missing and sexually exploited children. Member agencies are publicly recognized by NCMEC for meeting essential training and policy elements demonstrating preparedness for responding to a missing or sexually exploited child incident. There are no fees from NCMEC to become member agencies.

Program Criteria

Law enforcement agencies and emergency communications centers can become part of the Missing Kids Readiness Program by completing free online training, adopting or having written policies compatible with the NCMEC or IACP model policies for law enforcement agencies and the APCO ANSI standard for emergency communications centers.

Criteria

Chief or Sheriff of a LE agency or PSAP Director/Manager attends CEOMEC seminar or completes all the Missing and Exploited Child modules for law enforcement or PSAP course, respectively.



All sworn personnel or telecommunicators complete required online modules in their respective course catalog.

LE agency adopt LE Model Policy (or a policy meeting critical components of the model policy) and PSAP agency adopts ANSI Standards (or a policy meeting critical elements of the ANSI Standard) and addresses quality assurance review.
